Horsham District Council is reviewing the adopted Core Strategy (2007). The first stage in the process is the 'Leading Change in Partnership to 2026 and Beyond' Consultation Document, which sets out some of the key issues in planning the future of the District and some options for how they can be addressed and how the development requirements can be met.

The Consultation Document will be published for a six week public consultation period on 4 September 2009. Should you wish to comment on the document, please do so on or before **4.20pm on 16 October 2009**.

A number of background documents are also being published in support of the Consultation Document and these include a Sustainability Appraisal/Strategic Environmental Assessment (SA/SEA)/Equalities Impact Assessment (EqIA)/Health Impact Assessment (HIA) Scoping Report.
