# **STORRINGTON OLD MILL DRIVE PLANNING BRIEF SUPPLEMENTARY PLANNING DOCUMENT ADOPTION STATEMENT**

NOTICE is hereby given that in accordance with Regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2004, Horsham District Council will formally adopt its Old Mill Drive Diamond Planning Brief Supplementary Planning Document (SPD) on 13 June 2008.

The Old Mill Drive Diamond Planning Brief SPD sets out the Council's guidelines and vision for any future development of the Old Mill Drive Diamond site in Storrington. The document enables a more comprehensive joined-up development of the site that promotes improved links with the rest of the town centre and the wider community by interpreting general development plan policies on a more site-specific basis to help guide prospective developers.

Notice is also given that from 13 June 2008, in accordance with Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, the Sustainability Appraisal and Strategic Environmental Assessment of the Old Mill Drive Diamond Planning Brief Supplementary Planning Document (SPD) and its Adoption Statement can be viewed free of charge as set out below.

Any person aggrieved by the adoption of the Old Mill Drive Diamond Planning Brief SPD may make an application to the High Court for permission to apply for a judicial review of the decision to adopt the document. Any challenge must be made on the grounds that either the document has not been prepared within the powers conferred by the Planning and Compulsory Purchase Act 2004, or alternatively that a requirement of the Act or associated regulations has not been complied with. Any such application must be made promptly and in any event not later than 13 September 2008.
